### Objectives of IPR Facilitation Centre:-

- To provide support and facilities for searching/ mapping of IPRs including evaluation for possibility of registration for patents, industrial designs, trademarks, etc.
- To provide basic information and support about filing an IP application for patents, trademarks, copyrights, design, geographical indications (GI) etc.
- To facilitate IPR transfer and commercialization of technologies.
- To facilitate collaboration with potential clients for exploring possibilities for technology tie-ups and up scaling needs of any business enterprise.
- To provide and disseminate information on international IPR practices.
- To provide guidance in filing applications with national/ international agencies and execution of other documents concerning licensing, technology transfer agreements etc.
- To advice beneficiaries on legal remedies available on issues such as IPR infringements, duplication of IPRs such as patent/ TM/ Industrial design, etc.
